Greetings from AYUSHEXCIL

As you all are aware, in terms of clause 13(a) (i) of the Articles of Association of the AYUSHEXCIL, the membership of the council is on yearly basis (Financial Year April-March) and is required to be renewed from 1<sup>st</sup> April 2026. Renewal of membership charges for the year 2026–27 is Rs. 10,000 + 18% GST (Total Rs. 11,800/-)

For RCMC Holders: DGFT has implemented the electronic platform to facilitate electronic issuance/renewal/amendment of Registration Cum Membership Certificate (RCMC)/Registration Certificate (RC) and it has been made mandatory to renew/apply RCMC application through common digital RCMC portal only. Steps to apply for RENEWAL OF RCMC is mentioned in the attached file at point no 2.3. Renewal of Registration-cum Membership Certificate from page no.29 to 39.
